These Terms and Conditions govern your use of keydra.net ("Keydra", "we", "us", or "our"), including all purchases made through the platform. 1. Definitions

- "Account": A registered user profile on keydra.net.
- "Digital Goods": Keys, accounts, subscriptions, or other non-physical digital items sold.
- "Platform": The keydra.net website and related subdomains.
- "Customer" / "You": Any user or buyer on the platform.
- "Revealed Product": Any product where key/account credentials have been accessed.

2. Products and Delivery

- 2.1 Keydra sells digital goods such as game keys, pre-activated accounts, and subscriptions.
- 2.2 Most products are delivered instantly. Some may require manual fulfillment within 24 hours via redeem.joykon.co.
- 2.3 It is your responsibility to verify that your system and region are compatible with the product before purchase.

- 3.1 All game titles, logos, platform names, and trademarks belong to their respective owners.
- 3.2 We are not affiliated with or endorsed by publishers or platform holders (e.g., Steam, Sony, Microsoft).

 - Products are considered delivered once the key or credentials are shown.

6.2 Faulty Products:

A product is considered faulty if it is inaccessible, invalid, previously used, or revoked.

6.3 Reporting Deadlines:

- · Keys: 48 hours from delivery
- · Accounts: 72 hours from delivery
- Post-activation issues for Accounts: 30 days maximum

6.4 Non-Refundable Situations:

- · Product is revealed
- Wrong region/platform chosen
- · Chargeback before contacting us
- · Abuse or fraud detected
- Re-selling products without prior notice

6.5 How to Request:

- Submit a request via your Keydra user dashboard under the relevant order.
- Include your Order ID, issue description, and any screenshots.

6.6 Keydra+ Token System:

- Eligible members may use 1 reimbursement token for a refund/store credit.
- Requires 25+ orders, a valid Keydra+ subscription, and a clean record.
- Abuse leads to loss of token access and possible suspension.

6.7 Refund Method:

Refunds are issued to original payment method or store credit, at our discretion.
